Are you in middle or high school and between the ages of 14 and 21? Are you interested in law enforcement or seeing what being a Deputy Sheriff or Detention Deputy is all about?

### What does it TAKE to be a Sheriff's Explorer?

- \* Must be between the ages of 14 and 21.
- \* Must have no arrest history or criminal record.
- \* Must be a Lake County resident.
- \* Must attend a middle, high school, or in college.
- \* Must maintain a 2.0 or higher GPA.
- \* Must pay a \$ 40.00 application fee.
- \* Must submit to an illegal narcotics screening.
- \* Must submit to a background check and to an interview with LCSO staff members.

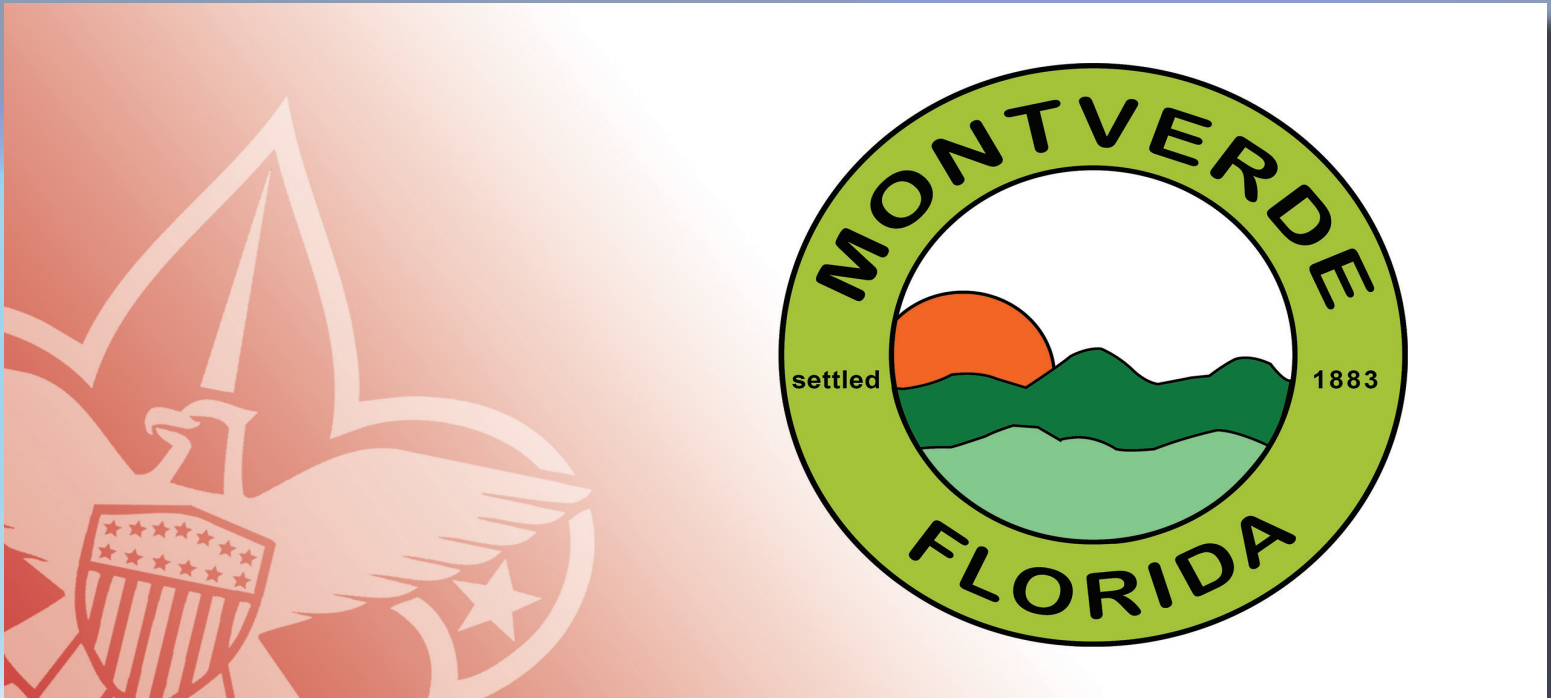
